

General Terms of Use of Parking Lot
Translation for information purposes

Part 1

1. The territory of this parking lot is a private property.
2. These General Terms of Use are binding on all persons (users of vehicles) who park their vehicles in this territory. When entering the parking lot, users of vehicles fully acknowledge these General Terms of Use as being binding on themselves as well as the owners of their vehicles.
3. The use of this parking lot is a paid service. This is a pre-paid parking lot and may be used 24 hours a day.
4. Payment for the duration of the use of the parking lot must be carried out in advance by using the pay-machine according to the specified tariffs.
5. Vehicles must be parked in the parking according to the signs and horizontal markings.

Part 2

1. Only registered vehicles (hereinafter – Car) are permitted to be parked in this parking lot.
2. Users of the parking lot are responsible for the security of the Cars parked in the parking lot. SIA “EuroPark Latvia” does not assume any liability regarding the security of the Cars parked within the parking lot.
3. The ticket received in the pay-machine or the contract card that confirms payment for the duration of the use of the parking lot, must be placed on the Car’s panel behind the windscreen in a clearly visible place to ensure that all the information regarding the payment indicated on the ticket or the contract card is readable from outside the Car.
4. Should it not prove being possible to verify the fact of the payment for the duration of the use of parking lot or if a Car is located within the parking lot for a period of time being longer than that specified on the ticket, as well as in the event that a Car is parked in the parking lot in violating the present General Terms of Use a penalty of 18 LVL (eighteen lats) will be imposed for every 24 hours issuing a relevant penalty claim. A wheel clamp may be placed on the Car’s wheel (in accordance with the rights of the seizure prescribed within The Civil Law of Latvia). The Car owner as well as the Car user shall be liable to pay the fee for the usage of the parking lot; the applied penalty shall be paid within 14 (fourteen) days from the date the penalty claim was issued using the attached payment order. If the penalty is not paid within the provided term, the collection of the penalty payment as well as the expenses related to the late payment will be transferred to the debt collecting company authorized by SIA “EuroPark Latvia”. Failure to pay applied penalty in time may result in data of the Car owner being obtained and published at a public debtor’s data base of SIA “EuroPark Latvia” authorized debt collecting company.
5. If a wheel clamp is placed, the user of the Car must call the telephone number indicated on the information signs or on the sheet placed on the Car’s windscreen. SIA “EuroPark Latvia” personnel will arrive at the parking lot within 30 minutes time following the call and will remove the wheel clamp after payment charge imposed by a car user.
6. In case a Car is located within the parking lot violating General Terms of Use in manner disturbing utilization of the parking lot by other users, SIA “EuroPark Latvia” is entitled for compulsory relocation or evacuation of a Car.
7. SIA “EuroPark Latvia” is entitled to bring a debt collection claim against the owner of the Car (including if the Car has been parked in the parking lot by a different person) for unpaid payments (for parking duration and penalty fees), as well as any losses incurred by SIA “EuroPark Latvia” in relation to the parking of the Car within the parking lot.
